Resolution of the ISG BOD to the “USA-Shagya-Araber situation”

Dear ladies and gentlemen,

since a lot of years we have to recognize, that the national discussion in USA about the organisation of Shagya-Araber breeding is impressed by interests of different groups. The consequence of this situation is a permanent conflict without using the chances of developing the breed and upbuild of a market for our shagya-arabian horses.

The actual ISG-BOD talked often about the unsatisfactory situation and we tried to find a solution in consideration of the particular interest of all Shagya-Araber breeders in USA and in the world. The key for the solution was the unanimous decisions of the annual conference in Kabiuk last year. On our last ISG-BOD conference a few weeks ago we agree for this one voice resolution:

- A. The assumptions for an ISG-acceptance for new member organisations (and of course for actual members) are:
- legal (governmental acceptance with according proof) organisation with the official allowness to organize breeding of horses with all necessary activities
 - acceptance and realisation of the ISG **General Studbook Regulation Framework (RZBO)**, as it was decided in Kabiuk 2007
 - approved studbook (list of all permissible breeding horse), checked and released by ISG (authorized examination)
- B. If these three points will be performed, than the assumptions for an ISG acceptance will be submitted, so the annual conference of ISG can decide the admission of another member organisation in USA

At least we set great store by your comprehension that the BOD is interested in a good and future oriented solution. This will be an extraordinary case for USA/North America, because of the huge geographic dimensions and the present situation. We hope that this resolution will open doors and could be helpful for a prosperous development of Shagya-Araber-breeding in your big country.
